Filing deadline for 2023 Form 3520 (Annual Return To Report Transactions With Foreign Trusts and Receipt of Certain Foreign Gifts).
Filing deadline for 2023 Form 114, Report of Foreign Bank Accounts (FBAR) with automatic extension granted to 16 October 2024.
Deadline for payment of 2023 Income Tax to avoid interest charges accruing.
Deadline for payment of first instalment of 2024 estimated tax.
17 June 2024 Filing deadline for 2023 Federal Income Tax Return for overseas taxpayers.
Deadline for payment of 2023 Income Tax to avoid late payment penalties accruing.
Deadline for payment of second instalment of 2024 estimated tax.
16 September 2024 Extended filing deadline for 2023 Form 3520-A.
Deadline for payment of third instalment of 2024 estimated tax.
15 October 2024 Extended filing deadline for 2023 Federal Income Tax Return and FBAR.

16 December 2024 Last possible extended filing date for 2023 Federal Income Tax Return (subject to IRS approval).
15 January 2025 Deadline for payment of final instalment of 2024 estimated tax.
